Use for commercial purposes is not permitted.”
- The inclusion of the phrase “All rights reserved. This work is protected by copyright. Any use outside the narrow limits of copyright law is prohibited.” or similar formulations as well as the use of licences restricting the CC BY or CC BY-NC licence in the publication are not permitted and legally invalid.
