In such cases, applicants are advised to contact the FWF Office for further information in order to ensure that the application is submitted properly.

In all cases, the applicant's research institution must be subject to the Austrian Universities Act (UG) 2002 or must have concluded an agreement with the FWF in this regard.
- ⁱⁱⁱ The personnel costs that can be requested for doctoral candidates are limited to a maximum of 30 hours/week. The basis for calculating personnel costs for fewer working hours is € 51,400.00 per year (=100%).
